3. **THIS COURT ORDERS** that (a) Representative Counsel shall represent the putative class in connection with the DGCL and (b) the putative class shall be bound by the actions of Representative Counsel with respect to the DGCL.

4. **THIS COURT HEREBY REQUESTS** the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in the United States, to give effect to this Order and to assist Representative Counsel and its respective agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to Representative Counsel, as may be necessary or desirable to give effect to this order, to grant representative status to Representative Counsel in any foreign proceeding, or to assist the Plaintiffs and Representative Counsel and their respective agents in carrying out the terms of this Order.
